**GENERAL INSTRUCTIONS TO THE BIDDERS**

The Director, ICAR-Central Research Institute for Jute & Allied Fibres, Barrackpore invites you to tender to bid for the auction of condemned **Infrared Thermometer**. The conditions governing the auction are attached, interested parties who intend to purchase the item mentioned above please submit your tender bids in the Store Section of **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120** on the prescribed tender form attached.

1. **Bid Security: Rs.2,000/-** (Rupees Two thousand) only in the form of Demand Draft drawn in favour of **"ICAR Unit-CRIJAF" payable at Barrackpore, Kolkata** in a sealed envelope super-scribed as **"Bid Security for AUCTION (Name of the work)"** on or before last date & time of submission of bids. In the absence of **Bid Security**, the tender will not be accepted. In no means Cheque will be accepted in this regard. **THE TENDER MAY NOT BE CONSIDERED IF THE BID SECURITY IS NOT SENT ALONG WITH TENDER.** No request for transfer of any previous deposit of earnest money will be entertained.

2. **Tender Cost:** The bidder should submit a demand draft of Rs.500/- (Rupees Five hundred) only towards non-refundable tender fee, drawn in favour of **"ICAR-UNIT-CRIJAF" payable at Barrackpore, Kolkata** in a sealed envelope super-scribed as **"Tender fee for (Name of the work)"** on or before last date & time of submission of bids. In the absence of **tender cost**, the tender will not be accepted. The tender documents are available in the **ICAR-CRIJAF website [www.crijaf.org.in](http://www.crijaf.org.in)**.

3. **PREPARATION OF TENDER:** The schedule to the tender form should be returned intact whether you are quoting for any item or not pages should be detached but when items are not being tendered for the corresponding space should be defaced by some such words as "Not Quoting".

**4. Signing of tender:** If complete information is not given in the tender form or if the particulars and date (if any) asked to the tender are not filled in the tender is also liable to be ignored. Specific attention must be paid to lifting dates and also to the conditions of the contract as the contract would be governed by these conditions.

**5. Latest Hour for receipt of Tender:** Unless specified in the schedule to tender, your tender must reach **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120** on or before 01:00 P.M. on 03.11.2018. Tender send by hand delivery should be put in the **TENDER BOX** at **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120** on or before 01:00 P.M. on 03.11.2018 unless otherwise stipulated in the schedule of tender. Last date of Submission of tender is **03.11.2018 at 01:00 P.M.** and opening of tender bids at **03:00 P.M. on 03.11.2018** at **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120..**

**6. Period for which the offer will remain open:** Firms which are sending their tenders should note that if desired that their offers should be remain open for acceptance for 90 days from the date of opening of tender. If the firms are unable to keep their offers open for the specified period they would specifically state in the tender for the period up to which they want their tenders to remain open for the period as specified in the schedule.

**7. Opening of Tender:** You are at liberty to be present or authorize a representative to be present at the opening of the tender at the time and date specified in the schedule. The name and address of the representative who would be attending at the time of opening of the tender on your behalf should be indicated in your tender, please also state the name and address of your permanent representative if any.

**8. Price:** The price quoted must be net per unit as shown in the schedule and must be clearly shown in figures and words in Indian Currency. The prices must be stated for each item separately.

**9. Terms of Delivery:** The firm whose tender is accepted will be required to lift the materials by the date specified in the schedule to tender, If, it is not possible for the successful tenderer to take delivery by date, the firm should be specify the date by which guarantee lifting in the prescribed schedule to the tender.

**10. Right to acceptance:** The council in its absolute right may accept the highest or any tender and reserves to itself the right of accepting the whole or any part of the tender or portion of the tender. You are at liberty to tender for the whole or any portion or to state in the tenderer form that the rate quoted shall apply only if the entire quantity is given to you.

**11. Arbitration:** Decision of the Director, ICAR-CRIJAF , Barrackpore will be final for any aspect of the contract and binding to all parties. Disputes arising if any on the contract will be settled at his/her level by mutual consultation and in case of failure of settlement dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-CRIJAF. The Decision of the arbitrator so appointed shall be final and

binding on the parties. Arbitration proceedings shall governed by the Arbitration and Constitution Act, 1996.

**12. Inspection :** For inspection of the instruments bidders may contact with the Dr. S. Mitra, Pr.Scientist & In-charge, AINPJAF, ICAR-CRIJAF, Nilganj, Barrackpore in between 02:00 P.M. and 04:00 P.M. from 20.10.2018 to 30.10.2018 at **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120** on any working day. No Counter conditions or relaxations mentioned in tender will be accepted.

**13. Taxes/ Insurance etc. :** All applicable taxes, if any, to be paid by the bidder over and above the Bid Price.

**14. Possesion:** Sale letter will be issued only in the name style and tenderer under which offer is made. Instruments should be removed from the **ICAR-CRIJAF, Nilganj, Barrackpore, Kolkata-700120** premises within 10 days from handling over sale letter. In case goods are not removed within 10 days, demurrage will be charged at the rate of Rs.500/- (Rupees Five Hundred) only per day per good and after 15 days Director, CRIJAF at his discretion may confiscate the amount deposited and dispose the good in the best interest of CRIJAF.
